Declaration of accessibility of the AGH University Press website

AGH University Press undertakes to ensure the accessibility of its website in accordance with the provisions of the Law of April 4, 2019 on Digital Accessibility of Websites and Mobile Applications of Public Entities. Status in terms of compliance with the law

The website is partially compliant with the Law on Digital Accessibility of Public Entity Websites and Mobile Applications due to the incompatibilities or exclusions listed below.

Inaccessible content

- Publications in the form of PDF files are partially accessible. The website posts files in two versions: PDF and DOC.
- Some of the published graphics do not have an alternative description, they are promotional in nature and are not used for current tasks.

Everyone has the right to:

- make comments on the availability of the digital site or its element,
- make a request to ensure the availability of the digital site or its element,
- request that the inaccessible information be made available in another alternative form.

The request must include:

- contact information of the person making the request,
- indication of the page or element of the page to which the request relates,
- indication of a convenient form of making the information available, if the request concerns making the inaccessible information available in an alternative form.

Consideration of the request should be carried out immediately, within 7 days at the latest. If within this period it is not possible to provide accessibility or provide access in an alternative form, it should take place within 2 months from the date of the request at the latest.

Complaints and appeals

If a public entity refuses to comply with a request to provide accessibility or an alternative means of accessing information, the requester may file a complaint about the provision of accessibility of a digital website, mobile application or an element of the website or mobile application. After exhausting the procedure indicated above, a request may also be submitted to the Commissioner for Human Rights.

Architectural accessibility

AGH University Press has its premises in the ALFA 1 Student House.

The main entrance to the building is located on Academic Street. There are stairs (12 steps) at the entrance to the building. This entrance is not accessible for wheelchair users.

An entrance on the side of the building from the parking lot, where the elevator to the building is located, has been adapted for wheelchair users. An intercom is installed at the elevator entrance to contact the gatehouse in case the gate is closed.

Corridors in the building provide free movement. There are no level differences in the circulation area, except for the access to the gatehouse. The stairs do not have special facilities for people with disabilities. There is a door between the elevator and the headquarters of AGH Publications, which remains closed on a daily basis. To open them, contact the gatehouse of DS. Alfa 1 or an employee of AGH University Press.

The parking lot on Akademicka Street is accessed from Reymonta Street (by the 'Polonez' hotel). Entrance to the parking lot is restricted by a barrier, at which there is an intercom. It is possible to apply for assistance from an AGH Guard employee. In this area there are three parking spaces designated for the disabled.
